Pricing for longer messages containing up to a maximum of 144 bytes of user data are charged at multiples of 36 bytes for the Standard Rate Schedule or at multiples of 9 bytes for Alternate Rate Schedules.

Pricing levels for any given month are based on the number of active STUs Reseller has on the last day of the monthly billing period for all Rate Schedules combined.
